## **Earned Income Credit Worksheet**

#### **General Information**

Effective for tax year 2022 and subsequent years, the Oklahoma Earned Income Credit (EIC) must be calculated using the same requirements for computing the EIC for federal income tax purposes in effect for the **2020 income tax year**. The 2023 Oklahoma EIC is based on your earned income for either tax year 2022 or 2023. The Oklahoma EIC is refundable beginning with tax year 2022. Complete Form 511-EIC using the attached EIC Table and **provide** a copy of Form 511-EIC with your income tax return.

**Part I –** Use the following worksheet to calculate your earned income. Or, use the worksheet provided in Part II of the Form 511-EIC if you were self-employed at any time during the applicable tax year, if you are filing IRS Schedule SE (Form 1040) because you were a member of the clergy or you had church employee income, or if you are filing IRS Schedule C (Form 1040) as a statutory employee.
