Section 2—Earned income

4. Enter the amount from line 15 of the *Earned income worksheet* (see instructions)..... 4.

Section 3—Initial amount

5. Enter the amount from line 2 or line 4 of the *Initial amount worksheet* (see instructions)..... 5.

6. Enter the amount of your partial federal EITC, if any, from federal Form 1040 or 1040-SR, line 27 (see instructions)..... 6.

7. Line 5 minus line 6. If zero or less, enter 0..... 7.

Section 4— Oregon credit for ITIN filers

8. **Credit percentage.** If your youngest qualifying child was two years old or younger at the end of the tax year, enter 12%. Otherwise, enter 09%... 8. %

9. **Credit amount.** Line 7 multiplied by line 8. Round to the nearest \$1 9.

10. **Oregon percentage.** If you were a part-year resident or nonresident in 2023, enter your Oregon percentage (Form OR-40-N or OR-40-P, line 35). If you were a full-year resident, enter 100.0 10. %

11. Line 9 multiplied by line 10. Round to the nearest \$1. **This is your Oregon EIC for ITIN filers.** Enter this amount on Schedule OR-ASC, section F or Schedule OR-ASC-NP, section H. Use code 898 11.
